#### Health Minister confirms two Nipah virus deaths in Kerala

CONTD. FROM PG-1 George said out of the five samples, three have

tested positive. "The samples of the person who died yester-day and two others under treatment, including the nine-year-old boy, have tested positive, she said.

The death of the first person, on August 30, was initially considered a death due to the comorbidity of liver cirrhosis, she said.

"However, his son, the nine-year-old boy who is already in ICU, and his 24-year-old brother-inlaw are the two positive cases that were detected today," the minister said.

The sample of the per-son who died yesterday also tested positive.

The minister added that two epicentres of the disease have been identified, which will soon be declared as containment zones by the district collector after following due procedure.

The man who died on August 30 was 44 years old, while the person who died vesterday as a 40-year-old man.

#### Retail inflation declines to 6.83% in August on falling food prices

As per the data, infla-tion in the vegetable basket eased to 26.14 per cent in August as against 37.4 per cent in July.
The prices of 'oil and

fats' products declined to 15.28 per cent in August while there was low inflation in 'meat and fish', 'eggs', 'sug-ar and confectionary', 'non-alcoholic beverages', 'fruits' and 'prepared meals and snacks' on an annual basis.

The data also showed that inflation in the 'housing' was at 4.38 per cent and 'fuel and light' at 4.31 per cent.

Aditi Nayar, Chief Economist, Head Re-search & Outreach at rating agency ICRA said that within food items. inflation in vegetables fell to 26.1 per cent in August from 37.4 per cent in the previous month, contributing as much as 28 basis points of the 61 basis points decline in the headline CPI inflation print between these months.

### New dress code for Parliament staff kicks off row

New Delhi A new dress code with floral motif for Parliament staff kicked off a political row on Tuesday with the Congress dubbing it as 'cheap" tactics to promote the ruling party's poll symbol.

According to an internal circular issued by the Lok Sabha Secretariat, the marshals, security staff and officials, chamber attendants and drivers have been issued new uniforms which they have to don once the new parliament building starts function-

ing. The 'bandhgala' suit of bureaucrats will be replaced with a magenta or deep pink Nehru jacket. The shirts for them will also have floral design. The employees will wear khaki-coloured pants.

The new attire for the marshals in both houses of Parliament will now include Manipuri turbans. The Parliament Security Staff will be seen in army camouflage pattern fatigues instead of the blue safari

Women officers have been assigned bright coloured sarees with jackets to be worn during winters.

The Congress accused

the BJP of making the "Parliament a one-sided partisan thing" and wondered why the lotus motif was used in the dress designs. Why lotus only? Why

can't a peacock or why can't a tiger? Oh, they're not BJP party election symbol. Why this fall sir Om Birla," Congress whip in Lok Sabha Manickam Tagore said on X. "How cheap they are.

# CISF seize gold paste worth Rs 1.3 crore at Mumbai airport, two held

Mumbai The Central Industrial Security Force (CISF) successfully intercepted and apprehended two passengers attempting to smuggle approxi-mately 2.5 kilograms of gold paste valued at around Rs 1.3 crore, officials said.

The incident occurred in the early hours of September 12, 2023, when CISF surveillance and intelligence staff at Terminal-2, CSMI Airport, Mumbai, noticed suspicious behavior from a passenger near the glass partition between domestic boarding gate No. 86 and 87 on Level 3. The passenger was placed under both electronic and physical surveillance, they said.

During the course of surveillance, a black pouch was observed being thrown from the



at International boarding gate No. 86 on Level 4. This prompted further investigation, an official

Subsequently, team detected CISF activities suspicious from another passenger, identified as Shajitha Begum, who appeared to be associated with the first passenger. The individuals were later identified as Jalal Y Jalaludeen and Shajitha Begum, both Indian citizens, who were scheduled to travel on Air India Flight

During the course of surveillance, a black pouch was observed being thrown from the glass partition situated at International boarding gate No. 86 on Level 4. This prompted further investigation, an official said.

No. AI609 bound for Coimbatore, he added. Both passengers were

immediately intercepted, and their hand baggage was subjected to further scrutiny in the Customs office. A joint interrogation was conducted by CISF and Customs officials, leading to the discovery of six oval-shaped yellow metal (gold) parcels wrapped in black tape within the handbags of both passengers.

Jalal Y Jalaludeen and Shajitha Begum admitted ownership of the gold paste and revealed that it had been handed to them by an international passenger who had discreetly thrown it over the glass partition separating the Domes-tic and International boarding gates. The seized gold paste,

weighing approximate-ly 2.5 kilograms and valued at around Rs 1.3 crore, was handed over to the Airport Intelligence Unit (AIU) and Customs officials for further legal action.

This operation highlights the vigilance and dedication of the CISF and Customs officials in preventing illegal activities at the airport, safeguarding national interests, and upholding the law. Investigations into the matter are ongoing.

# Supreme Court refers challenge to sedition law to Constitution Bench

New Delhi The Supreme Court on Tuesday referred to a Constitution bench of at least five judges a batch of pleas challenging the constitutional validity of the IPC provision on sedition, a month after the Centre introduced in Parliament bills to

replace the colonial-era penal statutes IPC, CrPC

A bench headed by Chief Justice D Y Chandrachud declined the Centre's request to defer the issue of reference to a larger bench as Parliament is in the process of re-enacting the provisions of the Indian Penal Code (IPC) and the Bill has now been placed before a standing com-



# Officials over power

woes

People faced power cuts for four to six hours in many areas of the city and countryside as the electricity system in the district collapsed due to trains.

Manesar, whose official name is Mohit Yadav, was accused by some of being a trigger for the July 31 episode, in which a Vishva Hindu Parishad procession was targeted by mobs in Nuh - leading to the deaths of six people in that district and neighbouring Gurugram.



However, the FIR registered by the Nuh police is related to a message he posted on social media amid plans by the VHP to take out another procession on August 28 to "resume" the disrupted yatra.

The Nuh police said the post attempted to create disharmony between groups on the basis of religion and wounded religious sentiments. It allegedly used objectionable language.





# Undercurrents of a strategically vital Gulf at the G20

ndia's hosting of the G20 Summit this month culminated in the successful release of a consensus-led 'Delhi Declaration,' despite fears that disagreements over Ukraine could lead to a stalemate. With an Indian wish to carry as many voices from the Global South as it could, West Asian (Middle East) representation was in full force with leaders from the United Arab Emirates (UAE), Saudi Arabia, Egypt, Türkiye, and Oman in attendance. Beyond the G20 obligations, Saudi Arabia's Crown Prince, Mohammed bin Salman (MbS), was also on a state visit. This coincided with the announcement of a India-Middle East-Europe Economic Corridor (IMEEC) along with the United States (US) as a major stakeholder.

While much attention was on India's ability to salvage the G20's position in the global multilateral order-as many questioned its relevance over a lack of deliverables on tackling poverty and climate-the representation from West Asia also showcased a rapidly increasing political and financial prominence of the Arab states in the region, The new economic corridor, which naturally got touted as a counter to China's Belt and Road Initiative (BRI), acted as a potpourri for the common economic interests of the participating states. However, there is much more brewing within the geopolitics and geoeconomics of the Gulf states than what was presented in New Delhi.

The Gulf is arguably where the West versus China competition is most visible today. Events over the past decade, such as the conflict in Yemen, attack on Saudi energy facilities by



Houthi militants that are known to have the backing of Tehran, and Western acceptance of the very idea of a nuclearised Iran, accelerated a shift in strategic thinking-one that was already underway. Amidst all this, the Gulf is increasingly seen as a beacon for global economics. While its prowess in hydrocarbons is well known, today, it is also home to 30 percent of overall container trade and 16 percent of all air cargo passage, with a geography that houses less than 6 percent of the global popula-

The above trends feed into the Gulf's growing importance, making their voice and partnership invaluable for New Delhi. Both the announcement of the IMEEC and visit of MbS increase the reliance of economic security between these two geographies. The challenge, however, remains an unstable global polity and a movement towards a bi-polar world order instead of a multipolar one that countries like India, Saudi Arabia, and the

UAE seek. This challenge will be a defining one for all, with the very definition of globalisation as we have known being contested.

The arrival of IMEEC

The announcement of the IMEEC connectivity project, currently at a Memorandum of Understanding (MoU) stage, expectedly grabbed headlines as a pound-for-pound answer to China's BRI initiative. On paper, the economic and political might IMEEC wields is, indeed, impressive as it attempts to bring together countries that can or have a track record of successful collaboration. Perhaps, not surprisingly, despite being geographically distant, excitement from the administration of US President Joe Biden was the most palpable. In New Delhi, where China-led economic designs are today being openly challenged, this enthusiasm will be wel-

However, IMEEC will have two realities to it. A geopolitical one, and an economic one. Connectivity projects joining India to West Asia and beyond make sense, nonetheless, successful connectivity projects in general, around the world, remain few and far between. However, much of the analysis on IMEEC since its announcement also misses some crucial points, both on the opportunities and challenges it faces. First, wisdom would be to look at IMEEC as a project that primarily feeds into the diversification of global supply chains and is not only about moving trade from one point to another. This means that it can use the political base set up by the Abraham Accords-which normalised relations between the UAE (along with others like Bahrain) and Israel-and the I2U2, a preexisting economic initiative between India, Israel, US, and the UAE. This would round up the IMEEC more wholesomely as an umbrella institution truly building new factories for the wider Global South. Its design should also look into

feeding manufacturing ca-

pacities in places such as Africa and Latin America.

The challenges for

IMEEC are also palpable.

To begin with, the idea for

the moment is academic at

best. History is littered with blueprints of connectivity projects that led nowhere. An intense political push would be needed for the IMEEC to move towards logical conclusions, considering the number of cooks in its kitchen. The two easy capitals to manocuvre will be Washington, D.C. and New Delhi, both having bipartisan support on a requirement to break Beijing's hold on global manufacturing and, by association, supply chains. Others in the Gulf. such as Riyadh and Abu Dhabi, come from different thinking. Both are members of China's BRI initiative, and actively seek Chinese investments. The other factor when it comes to financing IMEEC is a consensus looking towards the US as a primary financial provider. However, the real wealth today lies in sovereign wealth funds in the Gulf itself, thanks to cash rich coffers due to an energy boom and maintenance of high oil prices by OPEC+, which includes Russia. These cash-rich funds look for good investments, and projects like the IMEEC, which can feed into infrastructure expertise and technologies of the West, can make itself available as a good option.

Finally, a lot of the infrastructure to kickstart this initiative is already in place. It is now up to the policy mavens and political powers to offer a consensus-led initiative to the free market as one that is attractive to global business.

# Seabed warfare, Australia, India & the Indian Ocean

eabed warfare is now Sproliferating in Europe and has the potential to reach the Indian Ocean. A newly released ORF Issue Brief Indian Ocean Seabed Defence: Lessons from Europe looks at military operations in Europe that have targeted seabed cables (data and power), sensors and energy transmission and extraction infrastructure, and how Australia and India should be preparing for the seabed warfare threat.

Seabed warfare

The Russia-Ukraine conflict and wider Russia-Europe tensions have, in part, played out on the seabed. The sabotage of the Nord Stream 1 and 2 gas pipelines in September 2022 represented a return to the past, in which seabed infrastructure were targets for military operations. Three explosions were reported on 26 September 2022, which destroyed three of the four pipelines running from Russia to Germany. Nord Stream is no longer operational, exacerbating Europe's energy

Earlier, in January 2022, a communications cable servicing Norway's Svalbard Satellite Station was cut under mysterious circumstances. France also stances of cable sabotage in

Russia is conducting surreptitious and unauthorised surveys of critical seabed infrastructure across Europe, potentially as a prelude to disruption operations. Russia's Yantar intelligence collection ship was tracked loitering off the Irish coast in August 2021 in the vicinity of the future Celtic Norse communications cable (which will connect Ireland and Norway), as well as AE-Connect-1that links Ireland the United States (US). In November 2022, a Russian oceanographic ship was found loitering near offshore wind farms and an oil field in Denmark and the United Kingdom (UK). When approached by journalists at sea, masked men appeared on deck with Russian-style rifles and bullet-proof vests.

In addition to this publicly-reported Russian activity, it should be noted that all sides are playing offense in this new deep sea

> The Indian Ocean is a conduit for submarine cables that both connect Indian Ocean nations and send data further afield. But just as shipping is concentrated at oceanic choke points such as the Malacca Strait and Bab el-Mandeb Strait so too are submarine cables, making them vulnerable to attack at these locations.

> Subsea pipelines will also be of increasing importance in the Indian Ocean, especially for India. India's Oil and Natural Gas Corporation already operates thousands of kilometres of subsea pipelines off India's west coast, connecting major fields including Mumbai High, Neelam and Heera, Bassein. Iran is currently considering extending its subsea natural gas pipeline from Oman to India, which would connect to Porbandar in Gujarat. Further, a US\$5 billion undersea United Arab Emirates-India gas pipeline was proposed in May 2023, which would also connect

to Gujarat.

Australia is prioritising establishing offshore renewable infrastructure, including offshore wind and solar farms, wave energy plants and undersea interconnectors at various sites around Australia's coast, including the Indian Ocean. Australia may soon begin exporting solar power to Singapore via the world's longest undersea high voltage direct current cable, the Sub Cable Australia-Asia PowerLink.

Seabed mining exploration is also being undertaken in the Indian Ocean, where polymetallic nodules are in abundance. Such mining will involve a whole new range of players and seabed activities.

Indian Ocean solutions

It is clear that Australia and India share many interests in seabed security in the Indian Ocean.

This will require public discussion and debate on the implications of seabed warfare and how it should be integrated into respective Australian and Indian defence strategies. These should include governance arrangements for seabed warfare responses, capability requirements (e.g.,

vessels, unmanned and/or autonomous underwater vehicles, sensors, etc.), as well as articulating how human resources and partnerships in seabed warfare should be developed. France recently released its seabed warfare strategy in 2022, which may provide a useful model.

The Indian Ocean com-

prises various littoral and island nations, many of which do not possess sophisticated navies or coast guards, and there is no overarching grouping such as NATO to coordinate responses. As littoral Indian Ocean states with sophisticated navies and coast guards, Australia and India should take the lead in coordinating with less capable regional nations to monitor seabed infrastructure and develop plans for responses to disruptions. Australia and India can also assist these nations to consider seabed defence as part of regular defence reviews, Such cooperation could also include capability building in underwater domain awareness, capacity building programmes targeting seabed defence techniques, and adding seabed incident response scenarios to joint regional military exercises and

drills.

# SC declines Centre's request, refers pleas against sedition law to bench of "at least" five judges

he Supreme Court on Tuesday referred to a constitution bench of at least five judges a batch of pleas challenging the constitutional validity of the IPC provision on sedition, a month after the Centre introduced in Parliament bills to replace the colonial-era penal statutes IPC, CrPC and the Evidence Act, proposing among other things the repeal of the sedition law.

The apex court declined to accept the Centre's fervent request that reference of the petitions to a larger bench be deferred as Parliament is in the process of "re-enacting" the provisions of the Indian Penal Code (IPC) and a bill has been placed before a standing committee.

The court said assuming that the bill, which proposes among other things the repeal of the sedition law and introduction of a new provision with a wider definition of the offence, becomes a law, it cannot be applied with retrospective effect.

"We are not inclined to accept the request for deferring the consideration of the constitutional challenge in these batch of matters for more than one reason," said the bench headed by Chief Justice D Y Chandrachud. The bench, also comprising Justices J B Pardiwala and Manoj Misra observed that

### SC refuses to entertain Asaram's plea for suspension of sentence in rape case

New Delhi

The Supreme Court Tuesday refused to entertain a plea by disgraced self-styled godman Asaram, serving life term in a rape case, for suspension of sentence. A bench of Justices Sanjiv Khanna and SVN Bhatti told senior advocate Devadatt Kamat, appearing for Asaram, that the court is not inclined to entertain the petition and asked him to prepare for arguing the appeal before the high court against the life sentence awarded to him on April 25, 2018 by the Jodhpur trial court.

Kamat, while pleading the preacher's case, submitted he has been in jail for around 10 years and the high court has erred in not considering the aspect of his

ill health. "You should prepare for a regular appeal which is to come up for hearing before the high court," the bench said, adding it is inclined to dismiss his appeal filed against the Rajasthan High Court order of July 7, 2022. Kamat requested the court to not dismiss the appeal and said he is willing to

withdraw it. The bench then allowed him to withdraw the plea and said if Asaram's regular appeal against the conviction and sentence is not taken up for hearing expeditiously, he will be at liberty to file a fresh application for suspension of sentence be-

fore the high court. On July 7, 2022, the high court while noting that it is Asaram's third attempt to seek suspension of sentence, had dismissed his plea saying, "...looking to the nature and gravity of the allegations, and considering the fact that the appeal itself is ripe for hearing, we are of the opinion that the appellant (Asaram) does not deserve indulgence of bail. Hence, the instant application for suspension of sentences is rejected as being devoid of merit."



Section 124A (sedition) of the IPC continues to remain in the statute book, and even if the new bill becomes a law, there is a presumption that any new law in the penal statute will have prospective and not retrospective

"Consequently, the validity of the prosecution which would be launched so long as Section 124A continues to remain in the statute, will have to be assessed on that basis,"

The bench while noting the request by Attorney General R Venkataramani and Solicitor General Tushar Mehta to defer referring the petitions to a larger bench, said, 'There is no way we can avoid looking at the constitutionality of (Section) 124A on the ground of a new law .... "The bench noted the constitutional validity of Section 124A was tested by the

apex court on the basis of a

challenge that it was ultra vires to Article 19(1)(a) of the Constitution in the 1962 judgement of Kedar Nath Singh versus State of Bihar.

Article 19(1)(a) relates to the right to freedom of speech and expression.

The 1962 judgement had upheld the constitutionality of Section 124A and held it was in harmony with Article 19(1)(a).

The bench observed it needs to be noted that when the five-judge constitution bench had ruled on the validity of Section 124A in 1962. the challenge to it on the ground that it violated Article 19(1)(a) of the Constitution was tested only with respect to that Article.

It said at that time there was no challenge on the ground that Section 124A of the IPC violated Article 14 (equality before law) of the Constitution.

The top court said the ap-

propriate course of action for the three-judge bench would be to direct that the papers be placed before the CJI so the pleas could be heard by a bench of at least five judges since the 1962 decision was by a constitution

"We accordingly direct the registry to place the papers before the CJI so that appropriate decision can be taken on the administrative side for the constitution of a bench of a strength of at least five judges," the court

Senior advocate Kapil Sibal, appearing for the petitioners, said the matter needs to be considered as pending prosecutions are going on under Section 124A. Referring to the 1962 verdict, the bench observed, "We have a binding judgement of a five-judge bench." The CJI said as far as pending prosecutions under Section 124A are concerned, those will continue unless the new law says all prosecutions under this provision will lapse.

Senior advocate Gopal Sankaranarayanan, who also represented the petitioners' side, said even if a new law comes into effect, it can't be applied retrospectively.

The bench said there is an interim order of the apex court which stays prosecution for an offence under Section 124A but it will have to decide the constitutional

'So long as Kedar Nath holds the field, 124A is valid," the bench said, adding the proposed bench of five judges have to take a call on whether the 1962 verdict warrants reconsideration.

Before the court decided to refer the petitions to a bench of five judges, the two top government law officers pleaded with it to have the decision deferred. "We were to seek time on the ground that Parliament is seized of the matter. Now there is a new bill... it will have to be discussed on the floor of the House," the solicitor general said, adding the court may not like to "pre-empt" a dis-

"As the Attorney said, I am only supplementing him. Can it not wait? It has waited (for so long). Earlier governments had very good opportunity to say what Mr Sibal right now says that it is a draconian law. But they missed that opportunity. Now the government is in the midst of correcting," Mehta said.

Sibal responded saying, "What you have proposed is more draconian. That is the unfortunate part." Mehta told the court the government was of the view that all parties should be consulted on the issue before the bill becomes law and so it has been referred to the parliamentary standing committee. Sibal insisted the court should not wait for a law

to be passed by Parliament and instead decide on Section 124A as it stands today.

"In the colonial regime, it (Section 124A) was non-cognisable. We made it cognisable for the first time in 1973," the CJI observed.

On August 11, in a landmark move to overhaul colonial-era criminal laws, the Centre had introduced in the Lok Sabha three bills to replace the IPC, CrPC and the Indian Evidence Act, proposing among other things the repeal of sedition law and introducing a new provision with a wider definition of the

The top court had on May 11 last year put on hold the penal law on sedition till an "appropriate" government forum re-examined it and directed the Centre and states to not register any fresh FIR invoking the provision.

Besides the lodging of FIRs, ongoing probes, pending trials and all proceedings under the sedition law across the country will also be in abeyance, the top court had

The law on sedition, which provides for a maximum jail term of life under section 124A of the IPC for creating "disaffection towards the government", was brought into the penal code in 1890, a full 57 years before Independence and almost 30 years after the IPC came into be-

The Supreme Court on Tuesday extended till September 25 the interim bail of former Delhi minister Satyendar Jain in a money laundering case.

A bench of Justices AS Bopanna and Bela M Trivedi granted the relief to Jain after Additional Solicitor General SV Raju made a request for adjournment.

Senior advocate Abhishek Singhvi, appearing for Jain, also agreed to defer the matter.

The top court then postponed the matter to September 25 after extending the interim bail of the senior Aam Aadmi Party (AAP) leader.

It also directed another accused Ankush Jain to be released on interim bail for four weeks on medical grounds noting that

his child has to undergo surgery.

The top court had on May 26 granted interim bail to Jain for six weeks for spinal surgery, saying a citizen has a right to receive treatment of his choice in a private hospital at his own expense. It had extended the interim bail by five weeks on July

The ED had arrested the AAP leader on May 30 last year on the charge of laundering money through four companies allegedly linked to him.

The anti-money laundering agency had arrested Jain on the basis of a CBI FIR registered against him in 2017 under the Prevention of Corruption Act. He was granted regular bail by the trial court on September 6, 2019 in the case registered by the CBI.

### Rajnath launched 90 BRO infrastructure projects worth over Rs 2,900 crore

Union Defence Minister Rajnath Singh on Tuesday dedicated to the nation 90 infrastructure projects of Border Roads Organisation (BRO), worth over Rs 2,900 crore, spread across 11 States/Union Territories.

These include Nechiphu Tunnel in Arunachal Pradesh; two airfields in West Bengal; two helipads; 22 roads and 63 bridges. Of these 90 projects, 36 are in Arunachal Pradesh; 26 in Ladakh: 11 in Jammu & Kashmir; five in Mizoram; three in Himachal Pradesh; two each in Sikkim, Uttarakhand & West Bengal and one each in Nagaland. Rajasthan and Andaman & Nicobar Islands.

The BRO has completed the construction of these strategically-important projects in record time: most of them in a single working season using stateof-the-art technology.

In his address, the Raksha Mantri described the BRO as 'bro (brother)' of the Armed Forces, asserting that, through its infrastructure projects, BRO is not only securing India's borders, but also playing a key role in the socio-economic development of the far-flung areas.

Rainath Singh credited the timely completion of these projects to the hard work and dedication of its personnel as well as the commitment of the government under the leadership of Prime Minister Narendra Modi. "Together with BRO, we are ensuring that the nation is secure and border areas are developed. Timely completion of infrastructure projects in far-flung areas has now become the new normal of New India," he said.

Rajnath Singh was of the view that although R&D is a risky venture as it requires out-of-the-box thinking and sometimes does not give desired results, it still remains one of the basic elements for the development of any country. Hence, capital investment in R&D becomes a necessity, he emphasised.

"India is passing through a transitional phase. There is nothing wrong in acquiring a technology through imitation or transfer, but we cannot become a developed nation on these grounds alone. We need to file our own



patents, for which a lot of investment in R&D is needed. Capital investment in R&D may reduce today's profits, but it will prove to be beneficial to the industry and the country in the long term," Raksha Mantri said.

Rajnath Singh urged the industry partners to focus on creating a culture that encourages R&D, based on skilled human resources.

He suggested linking the work of institutes such as HTs, HMs and HSCs with the defence sector in order to create an R&D ecosystem in the field.

He added that efforts should be made to connect with the Indian R&D sector, the engineers and scientists

who work in top universities, companies, space agencies & scientific research organisations abroad and wish to be a part of India's growth He also recommended



# Libyan city buries 700 people killed in devastating floods as 10k reported missing

ibya's eastern city of Derna has buried 700 people killed in devastating flooding and 10,000 were reported missing as rescuer teams struggled to retrieve many more bodies from the horrific deluge, officials said Tuesday.

Mediterranean storm Daniel on Sunday night caused havoc and flash flooding in many towns in eastern Libya but the worst destruction was in Dema, where heavy rainfall and floods broke dams and washed away entire neighbourhoods, authorities said.

"The situation is catastrophic," said Othman Abduljaleel, the health minister in Libva's eastern government. "The bodies are still lying on the ground in many parts (of the city). Hospitals



Tamer Ramadan, Libya envoy for the International Federation of Red Cross and Red Crescent Societies, said 10,000 people were missing after the unprecedented flooding. Speaking to reporters at a UN briefing in

from Tunisia, he said the death toll was "huge" and expected to reach into the thousands in the coming

Referring to Friday's devastating earthquake in Morocco, on the other side of North Africa, Ramadan said the situation in Libya was "as devastating as the situation in Morocco".

Ossama Hamad, prime minister of the government in eastern Libva, said that many of the missing were believed to have been carried away after two upstream dams burst. He said the devastation in Derna is far beyond the capabilities of his country.

After more than a decade of chaos, Libya remains divided between two rival administrations: one in the east and one in the west, each

backed by different militias and foreign governments. The conflict has left the oil rich North African country with crumbling and inadequate infrastructure.

Derna was declared a disaster zone and more bodies were still under the rubble in the city's neighbourhoods, or washed away to the sea, according to Abduljaleel, the health minister.

Residents posted videos online showing major devastation. Entire residential blocks were erased along Wadi Derna, a river that runs down from the mountains through the city centre. Multi-story apartment buildings that once stood well back from the river were partially collapsed into mud.

Abduljaleel said the city was inaccessible and bodies were scattered all over, ac-

cording to Libya's state-run news agency. "The situation was more significant and worse than we expected...An international intervention is needed," he was quoted as

Emergency responders, including troops, government workers, volunteers and residents were digging through rubble to recover the dead. They also used inflatable boats to retrieve bodies from the water. Excavators and other equipment have yet to arrive in Derna.

Many residents described scenes of chaos when floods hit the centre. They heard loud explosions at night and realised that dams outside the city collapsed, sending a wall of water that "erased everything in its way," said Ahmed Abdalla, a Derna res-

Opinion polls indicate that Trump is by far the strongest contender to become the Republican Party's candidate in the 2024 presidential election. During his four years in the White House, Trump repeatedly touted having good relations with Putin, while critics alleged he was submissive to the Russian leader.

Trump has claimed he could resolve the conflict in Ukraine in a matter of days, if he regains the presidency. He has not provided details of his potential approach.

We hear that Mr. Trump says that he will solve pressing problems in a few days, including the Ukrainian crisis. Well, this cannot but bring happiness. This is good," Putin said.

However, the Russian leader said his country's poor relations with the United States were unlikely to change significantly regardless of who becomes president.

"What to expect from the future, no matter who the president is, it's hard for us to say, but it's unlikely that anything will change radically," Putin said.

He claimed the Biden administration has instilled a strong bias against Russia and "it will be very difficult for them to somehow turn this whole ship" in the other direction.

Russia also is due to have a presidential election in 2024. Putin hedged Tuesday when asked if he would seek another term after being in power, as president or prime minister, since 2000.

# 2 Indo-Canadian Sikhs sentenced for role in murder of man over drug debt

London

Two 24-year-old Indo-Canadian Sikhs have been sentenced for their roles in the 2019 targeted killing of a man in British Columbia over a drug debt, according to a media report.

Andrew Baldwin, 30, was stabbed to death on November 11, 2019, while he watched a movie with a friend in a basement apart-Jagpal Singh Hothi, now

24, was charged with first-degree murder but pleaded guilty to the lesser charge of manslaughter and was sentenced to three years in prison, with about 3 1/2 months' credit for pretrial



time served, Justice Martha M. Devlin wrote in the British Columbia Supreme Court judgments, the Vancouver Sun reported on Monday.

Jasman Singh Basran, also 24, who tried to get rid of evidence, was charged with being an accessory after the fact but pleaded guilty to the lesser charge of obstruction of justice. He was sentenced to 18 months to be served as a conditional sentence, meaning under curfew in his own home, the report added.

Earlier this summer, Devlin sentenced a third man, Jordan Bottomley, who was found to have stabbed Baldwin six times, once fatally in the heart, in a bloody attack that was over in less than 90 seconds.

He also pleaded guilty to manslaughter after being charged with first-degree murder. His sentence of eight years was reduced to three years and 38 days after subtracting the pre-trial custody credit.

A fourth person, Munroop Hayer, who was not present at the killing, has been charged with first-degree murder and has yet to face

Devlin wrote in the three separate judgments how Bottomley, Hothi and Baldwin worked for a fourth man in the local drug trade. Hothi was asked by that fourth man to pick up Bottomley and drive him to collect on a drug debt that Baldwin owed.

Hothi called his friend, Basran, who had a truck, to do the driving, without telling Basran where they were go-


## additional GST on diesel cars New Delhi oad Transport and the need to levy an additional 10 per cent tax on diesel-

Highways Minister Nitin Gadkari on Tuesday spoke of run vehicles to help cut emissions, but later clarified that there was no proposal under government consideration to impose such a tax.

Speaking at the annual convention of automobile manufacturers body SIAM, Gadkari said rising pollution level is a serious health concern and there is a case for increasing taxes to dissuade sale of diesel vehicles.

"I am requesting the Finance Minister to impose an additional 10 per cent GST on diesel engines/vehicles. This is the only way to phase out diesel vehicles," he said, indicating a meeting was scheduled with the Finance Minister for handing over a letter he had drafted on the

But soon after he took to X, formerly known as Twitter, to clarify the government's po-



"It is essential to clarify that there is no such proposal currently under active consideration by the government," he said in a post on X, referring to media reports quoting him as suggesting an additional 10 per cent GST on diesel vehicles.

He emphasised that there was a need to embrace cleaner fuels to cut emissions.

"In line with our commitments to achieve Carbon Net Zero by 2070 and to reduce air pollution levels caused by hazardous fuels like diesel, as well as the rapid growth in automobile sales, it is imperative to actively embrace cleaner and greener alternative fuels. These fuels should be import substitutes, cost-effective, indigenous, and pollution-free," he said on X.

At the Society of Indian Automobile Manufacturers (SIAM) convention, he had warned that the government would increase taxes so much that it would become difficult to sell diesel vehicles.

Most of the commercial vehicles in the country cur-

rently run on diesel.

In the passenger vehicle segment, various carmakers including Maruti Suzuki India and Honda have already stopped manufacturing diesel cars.

Gadkari said the contribution of diesel cars has already come down drastically in the country and the manufacturers need to stop selling them in the market.

The minister also highlighted that India is utilising a major portion of fossil fuels in the transport sector which is posing a big economic as well as pollution challenge.

He suggested alternatives such as biofuels, ethanol and green hydrogen in addition to electric vehicles.

At the SIAM annual convention, the minister said the country is making good roads across the country, which is leading to the growth of the automobile industry.

"The auto industry is growing at 15-18 per cent and it is also leading to enhanced usage of fossil fuels. If this goes on like this, you (companies)

will be happy, but pollution will make the people of this country sad. So quickly leave petrol, diesel. Please focus on alternatives, this is my request to you," Gadkari said.

He further said, "I will request the finance minister for 10 per cent pollution tax as additional GST on all such engines utilising diesel, from generator sets to vehicle engines." Seeking cooperation from the auto industry, Gadkari said, "I think you will not force me to push this proposal... this is the appropriate time, it is not rocket science, this is already everywhere in the world... so I will request you all to take suo moto initiative and cooperate with us in moving away from diesel/petrol, this is my humble request." Terming diesel as a hazardous fuel, he noted that the country has to import the fuel to meet the demand.

"Say goodbye to diesel... Please stop making them, otherwise, we will just increase the tax so much that it would become difficult to sell diesel cars" Gadkari said.

# Wellalage, Asalanka run through star-studded India on turning track

ri Lankan duo of Dunith Wellalage and part-timer Charith Asalanka spun a web around the Indian batters on a turning track, restricting them to a subpar 213 in their Asia Cup Super 4 match here on Tuesday.

Left-arm spinner Wellalage (5/40), all of 20, and offie Asalanka (4/18) knifed through the star-studded line-up after India opted to bat.

But before spinners exploited the generous turn and grip on the Premadasa pitch, India started their innings in a blazing fashion.

Rohit Sharma, who made 53 off 48 balls, added 80 runs for the opening wicket with Shubman Gill (19), and that remained the brightest phase of Indian innings.

Watching Rohit and Gill adding those runs in just 12 overs rekindled the memories of India's blitz against Pakistan on Monday, when they posted a massive 356 for two.

During his innings, the Indian captain also went past a significant personal milestone, becoming the sixth Indian batsmen to score 10000 runs in ODIs.

The landmark came in a befitting fashion too, as Robit lifted pacer Kasun Rajita over his head for a majestic six. Other Indian batsmen to reach the



mark are: Sachin Tendulkar, Souray Ganguly, Rahul Dravid, Virat Kohli and MS Dhoni. Indeed, a magnificent company to be in! However, the introduction of Wellalage changed the whole complexion of the game as the spinner halted Indian batsmen's charge.

Gill was the first to go. The opener played a forward defence without entirely covering the line and once the ball beat his bat, Gill's fate was sealed.

Wellalage, a former under-19 captain of his country, then went on to show why he has been spoken so highly in Lankan cricketing circles.

He bowled a straight, quick delivery and Rohit could not bring his bat down on time, as the ball rearranged his tim-

But Wellalage wasn't finished yet. He added the wickets of Virat Kohli (3), KL Rahul (39), who added 63 runs

with Ishan Kishan (33) for the fourth wicket, and Hardik Pandya (5) to his kitty for his maiden five-wicket haul in ODI

None of the following batsmen also could effectively negate the uneven bounce and turn on the pitch, as Asalanka wreaked havoc.

His delivery to dismiss Ravindra Jadeja would carry a lot of repeat value. The ball reared from the length, turned and bounced viciously to take an edge of Jadeja's bat before nestling in stumper Kusal Mendis' gloves.

Now, the Indian spin troika of Kuldeep Yadav, Axar Patel and Jadeja will have to replicate the performance of their Lankan counterparts.

For India, a win against Lanka will assure them a place in the final with four

A defeat will not harm India, but they will need a victory against Bangladesh

Their current NRR of +4.56, which will dip a bit if they lose this match, too might come handy in the event of an equation tussle with Pakistan and Sri

If India will have to split points on Tuesday after a washout, then they will enter the final with three points, awaiting either Lanka or Pakistan in the summit clash.

# Chahal bags 3/63 County Championship debut for Kent



India leg-spinner Yuzvendra Chahal has made an impressive start to his County Championship stint with Kent, claiming three wickets against Nottinghamshire in a Division One fixture here on Tuesday. Snubbed by the national selectors for the ongoing Asia Cup and the upcoming World Cup, the 33-year-old returned 29-10-63-3. Chahal dismissed Nottinghamshire batters Matthew Montgomery, Lyndon James and Calvin Harrison to help his side bowl out their opponents for 265 as Kent took a first innings lead of 181 on the penultimate day of the four-day con-

For his first wicket, Chahal cleaned up James with a superb leg break delivery which knocked down the batter's off-stump. Earlier this season, Kent had signed up India pacer Arshdeep Singh who played five matches and took 13 wickets.

Chahal has been a regular member of the Indian T20 side but has not played ODI cricket since January this year. His last assignment with the Indian team was in their five-match T20I series against the West Indies. The leg-spinner signed up with Kent for three County matches, at home against Nottinghamshire and Lancashire and for an away fixture against



### Rohit Sharma sixth Indian to amass 10,000 ODI runs

Colombo

India captain Rohit Sharma on Tuesday became the sixth batter from his country and 15th overall to complete 10,000 ODI runs. Rohit achieved the feat during India's Asia Cup Super 4 contest against Sri Lanka here. The India skipper hit a six off Sri Lanka's Kasun Rajitha to complete the milestone in the seventh over of the innings, a day after Virat Kohli became the quickest ever batter to cross 13,000-run landmark in a record 267 ODI innings. In fact, Robit completed his 10,000 runs in 241 innings, which is second fastest ever after Kohli did so in 205 innings.

The other Indians in the 10,000run club are Sachin Tendulkar (18,426 runs), Virat Kohli (13,026), Sourav Ganguly (11,363), Rahul Dravid (10,889) and MS Dhoni

As the only player in the history to have hit three double centuries in 50overs cricket, Rohit also holds the record of most runs in an innings or the highest individual score -264 against Sri Lanka at Eden Gardens in November 2014. Rohit recorded his first ODI double ton against Australia in November 2013 when he scored 209. Four years later, he smashed another double ton against Sri Lanka - 208 not out at Mohali in December 2017. With 30 centuries so far, Rohit is at joint-third with former Australia captain Ricky Ponting for hitting most ODI hundreds. He is also third in the list of batters with most sixes in the format.

### Babar Azam bags third ICC Men's Player of the Month award

Karachi Pakistan skipper Babar Azam claimed the ICC Men's Player of the Month award for the third time, bagging the award for August 2023. Babar who currently sits comfortably at the summit of the ODI rankings continued to impress with bat in the month of August.

His richness of form was reflected in his performances as he struck two fifties and a century. In Pakistan's ODI series against Afghanistan, Babar struck two fifties in the final two matches. He brought up a 118-run stand with Imamul-Haq in the second ODI that laid the foundation for a thrilling last-over finale. Babar contributed 53 runs with the bat and was backed by Imam (91 runs) and the lower order. Babar didn't stop there, he replicat-

ed his performance in the 3rd ODI with his exquisite knock of 60. His sublime batting skills were on display in the Asia Cup opener against Nepal. Babar's knock of 151 made him the first captain in the Asia Cup to score 150 or more than that. "I am delighted to be named ICC Player of the Month for August 2023. The past month has been extraordinary for my team and I have put some terrific performances. With the Asia Cup coming to Pakistan after such a long time, it was great to play in front of the passionate and cricket-loving crowds of Multan and Lahore. That I scored my second ODI score of 150-plus in front of my own people in Multan doubled the joy," Babar said as



quoted from ICC.

"I am looking forward to making the most of the form as we head into an exciting phase of cricket with the backend of the Asia Cup nearing and the ICC Men's Cricket World Cup around the corner. My team and I are eager to bring joy and happiness to the millions of Pakistan fans," Babar added. The versatile Pakistan skipper will be back in action in the Asia Cup Super Four against Sri Lanka on Thursday.

# I was initially nervous, says KL Rahul on his comeback match

Returning to action after a long injury layoff, India wicketkeeper batter KL Rahul says he was a bundle of nerves and it took him some time to settle down before going for his shots against a quality Pakistan attack in the Asia Cup in Colombo.

The 31-year-old, who had suffered a debilitating thigh injury during the IPL which later necessitated a surgery, smashed an unconquered 106-ball 111 to play a vîtal role în India's massive 228-run win over Pakistan on Monday.

"Obviously, this is my first international match after a long time. I played a couple of practice games, but we all know the intensity is not the same. So when I walked in, I had that initial nervousness," Rahul told Star Sports after his sixth ODI hundred.

"It took me 10-15 balls to just calm myself down and get my feet moving, get my mind thinking of the right things. Then, when I hit one or two boundaries, all those things, the fogginess in your clarity, went away, and it became like before." Rain interruptions made things further difficult as Rahul and Virat Kohli (122 not out) had to restart the India innings, which was suspended on Sunday because of rain, at 147 for two in 24.1 overs.

"I was looking at the ball, looking at the situation, and you see what you have to do. But just when I got my rhythm,

it started raining...and I had to wait for a whole day," Rahul said.

"Today we came back and had to wait for the innings to start. So I had to restart the innings again. So, again, the first 10-15 balls were sort of nervy, and after that, once you start to hit a few balls in the middle, you forget about those things, and then you start thinking about where you can score runs and what I have to do." Rahul, who underwent rehabilitation at the National Cricket Academy (NCA) in Bengaluru to get fit for the Asia Cup but missed the first two group matches due to a niggle, forged a 233-run stand with Kohli for the unconquered third wicket to power India to 356-2.

Talking about his partnership with Kohli, Rahul said: "He has hit 13,000 runs. I can't say anything about that man; he is just phenomenal. Words are short to describe what a great cricketer he is, and I've always felt comfortable playing with him in the middle.

"Initially, he gave me some time: I had said that I need some time to get those quick singles because I need to feel comfortable and confident in my body, and he understood that. After that, it was just a flow.

Former captain Sune Luus (up four places to 24th in the batting list), Lara Goodall (up five places to 37th in the batting list) and Masabata Klaas (re-entered at 28th in the bowling list) are other South Africa players to gain while Aliya Riaz (up three places to 30th in the batting list) and Sadia Iqbal (up six places to 63rd in bowling) are the Pakistan players to gain in the latest update that also takes



the first match of the IWC series between England and Sri Lanka.

England opener Emma Lamb has gained seven positions to reach 42nd position among batters and Sarah Glenn is up eight places to 64th after finishing with three wickets in the match at Chester-le-Street that their team won by seven wickets. # Kuruniyan ACL tear sparks row, Mohun Bagan 'refuse' to release players for Asian Games

ohun Bagan Super Giant are "furious" with the way Ashique Kuruniyan's injury was handled by the Indian physio during their King's Cup match against Iraq and have decided not to release their players for the upcoming Asian Games.

The reigning Indian Super League champions, who are slated to begin their AFC Cup group stage campaign on September 19, have two players -- Liston Colaco and Ashish Rai -- in the 22member squad for the Hangzhou showpiece whose football matches will begin on September 19.

The 26-year-old India midfielder sustained an injury around the hour mark and had to be replaced by Rahim Ali in their King's Cup semifinal match against Iraq on September 7.

An MRI on Kuruniyan revealed an ACL (Anterior Cruciate Ligament) tear and Mohun Bagan will form a medical board to address the issue, a Mohun Bagan official said on Tuesday.

"For five days, they neglected his injury and didn't even conduct an MRI.



This is not something we'd expect from a Team India physio," he asserted.

"If they had performed an MRI, we could have started physiotherapy earlier and minimised the extent of the injury." "In light of this episode, there is absolutely no consideration of releasing our players for the Asian Games," he

If it's a long-term injury then Mohun Bagan may also seek compensation, the team official further said.

The All India Football Federation (AIFF) had earlier urged the 10 Indian Super League franchises to release players selected for the upcoming Asian Games keeping the "national interest in

"We all have the responsibility towards the country to make India proud... As Indians we are obliged to make sacrifices for the country and, in this process, you have to take a decision by releasing the players considering the National interest in mind," AIFF secretary general Shaji Prabhakaran had written to the clubs whose players figure in the 22-member Indian squad.

The Igor Stimac-coached side will begin its campaign against hosts China on September 19, followed by matches against Bangladesh (September 21) and Myanmar (September 24).

The dates are clashing with Mohun Bagan's AFC Cup and Indian Super League fixtures. Two-time Inter-zonal semifinalists Mohun Bagan begin their AFC Cup group campaign against Odisha FC in Bhubaneswar on September 19 and they are slated to leave a day before.

In the ISL, which starts on September 21, the reigning champions have their first three matches on September 23 (Punjab FC), September 27 (Bengaluru FC) and October 7 (Chennaiyin

### India go down to UAE in AFC U-23 Asian Cup Qualifiers

New Delhi

India ended their AFC U-23 Asian Cup 2024 Qualification campaign with their second loss in as many matches, as UAE defeated them 3-0 at Dalian Suovuwan Stadium, in Dalian, China, on Tuesday, September 12, 2023. With this defeat, while India finished at the bottom of Group G, they also played spoilsport for hosts China PR, to beat India 2-1 in an earlier match. It was a do-or-die match for both sides; a win by two or more goals would guarantee UAE the top spot in Group G of the AFC U-23 Asian Cup 2024 Qualifiers, while three points would give India a chance to qualify as one of the four best second-placed teams out of the 11 groups.

With a victory of 3-o margin, UAE finished on top of Group G with four points and a better goal difference. China who ended with four points too, have an outside chance of making the next round as one of the four best second-placed teams. Both sides sensed the urgency and began the match at great intensity, tackles flying in both halves of the pitch. Jiteshwor Singh picked up a booking around the quarter-hour mark for a tackle in the middle of the pitch.

The UAE managed to take the lead in the 26th minute as the Indian defenders were left rather confused after a melee inside the box. Mohammed Abbas Alblooshi was finally awarded the goal after a lengthy discussion between the referee and his assistant. The side from the Persian Gulf doubled their lead just three minutes after the half-hour mark, when Sultan Adil Alameeri's low drive from inside the box found

the back of the net. Sensing the game slipping away from under their feet, India began to rotate the ball around the park, looking for openings. However, for all their intent, the UAE back-line managed to keep them at bay. After the change of ends, India looked to put some pressure on the UAE defence. Parthib Gogoi made a foray down the right into the attacking third early in the second half, but his cross evaded all the forwards.

India head coach Clifford Miranda made a couple of changes, bringing on Rabeeh Anjukandan and Sourav in place of Sanjeev Stalin and Parthib Gogoi a little after the hour mark, as they looked to pull one back. However, UAE sat back and waited for the perfect opportunity to spring a counter-attack. Goalkeeper Hamad Abdulla Almeqbaali launched a long ball forward, as Eisa Khalfan finished off the move, to make it 3-o.

More changes were in store for India as Rohit Danu and Ayush Chhetri replaced Suhail Bhat and Jiteshwor Singh, followed by the final substitution of the day for India, as Amarjit Singh Kiyam replaced Vibin Mohanan. Three substitutes combined with 18 minutes of regulation time left, as Danu cut it back to Rabeeh, who passed it on to Souray, whose shot was blocked.

# FIH withdraws hockey Olympic Qualifiers from Pakistan: PHF source

In a significant blow for Pakistan hockey, the world body (FIH) has taken away the hosting rights of the Olympic Qualifying tournament from the country because of infighting between the national federation and the nation's Sports Board. The Olympic Qualification tournament is scheduled to be held in January next year. The International Hockey Federation's decision came as a result of the ongoing tussle between the Pakistan Hockey Federation (PHF) and the state-owned Pakistan Sports Board (PSB).

"The FIH while taking away our hosting rights made it clear it was convinced that the sports board and government were not willing to cooperate with the PHF in the successful hosting of the event," a PHF source

The FIH's decision came as a big jolt to Pakistan hockey which had got the rights to host an international event after over a decade. The PHF had already announced that the Olympic Qualifier would be held in Lahore in January.



But recent attempts by the PSB to interfere in PHF affairs in a bid to plant its own people in the federation has led to the chaos. Several Olympians encouraged by the government's ministry of inter provincial coordination and PSB have been trying to stage a coup in the PHF and get a vote of no confidence passed against the sitting president, Brigadier (retd) Khalid Sajjad Khokar and secretary Haider Hussain.

The Olympians include Asif Bajwa, Shahbaz Ahmed and Rana Mujahid, who served as secretaries in recent times, two of them under Khokar.

# AIFF hoping clubs would release any 22 players from list of 50 for Asian Games

The All India Football Federation (AIFF) is hoping that the ISL clubs would release any 22 players from the registered 50 for the upcoming Asian Games, allowing the senior men's team to participate in the continental showpiece.

Most of the clubs had shown unwillingness to release the 22 players named in the Indian squad that was released by the sports ministry, as the Asian Games' football competition schedule clashes with the ISL, which starts on September 21.

The federation has also not ruled out the possibility of star players Sunil Chhetri, Sandesh Jhingan and Gurpreet Singh Sandhu travelling to Hangzhou, China with the team for the quadrennial extravaganza. While the Games are scheduled from September 23 to October 8, the football event will kick off on September 19 and continue till October 7. "AIFF is putting every effort to convince the clubs to cooperate to send the strongest national team to the Games," a top official of the federation told PTI on Tuesday. A federation source added, "AIFF is still negotiating but there is no clarity yet. Chhetri, Jhingan and Gurpreet are still not ruled out. It's up to the clubs to release



players they wish to. Any 22 from the long list of 50 will do." Bengaluru FC, FC Goa and Mohun Bagan Super Giants are among clubs who are not willing to release their players for the Games.

The Indian Super League schedule was announced earlier this month amid doubts over the release of a few India players by clubs for the Asian

The league clashes with the Asian Games where the football competition begins on September 19 and continues

The 22-member Indian men's squad

for the Asian Games has players from 10 ISL clubs and some of them are reluctant to release their players.

Out of the 22 players named in the squad, six are from Bengaluru FC, three from Mumbai City FC, while FC Goa, Mohun Bagan, East Bengal, Odisha FC, Kerala Blasters have two each. Newly-promoted Punjab FC, Chennaiyin FC and Hyderabad FC have one each.

The AIFF had also written to the 10 ISL clubs to release their players selected for the Asian Games, keeping the "national interest in mind".
